2 3 4	AN ORDINANCE OF THE CITY OF RIVERSIDE, CALIFORNIA, ESTABLISHING THE LEVEL OF COMPENSATION OF THE MAYOR AND PROVIDING CERTAIN FRINGE BENEFITS, AND RESCINDING ORDINANCE NO. 7278 IN ITS ENTIRETY.

6	The City Council of the City of Riverside, California, does ordain as follows:
7	Section 1: Effective 30 days after adoption of this ordinance, and beginning with the
8	first pay period thereafter, the Mayor shall receive compensation of (\$) per
9	month. Said compensation shall be payable at the same time and manner as compensation of
10	other officers and employees of the City.
11	Section 2: The Mayor shall receive those fringe benefits as are currently available to and
12	have been established for the City Executive Management employees with the exception of sick
13	leave and vacation accruals pursuant to the City's Fringe Benefits Resolution.
14	Section 3: Ordinance No. 7278 is rescinded in its entirety.
15	Section 4: The City Clerk shall certify to the adoption of this ordinance and cause
16	publication once in a newspaper of general circulation in accordance with Section 414 of the
17	Charter of the City of Riverside. This ordinance shall become effective on the 30 <sup>th</sup> day after the
18	date of its adoption.
