

FIRST AMENDMENT TO MEMORANDUM OF UNDERSTANDING

Between the John Muir Charter School and the City of Riverside

THIS FIRST AMENDMENT TO MEMORANDUM OF UNDERSTANDING ("First Amendment") is made and entered into this 2nd day of July, 2013, by and between the JOHN MUIR CHARTER SCHOOL, a Nevada non-profit public-benefit corporation ("Muir") and the CITY OF RIVERSIDE, a California charter city and municipal corporation ("City") with respect to the following facts:

RECITALS

WHEREAS, Muir and City entered into Memorandum of Understanding in order to collaboratively provide high school students in Riverside with the best education opportunities possible ("MOU") on July 2, 2013; and

WHEREAS, City and District have agreed to amend the MOU pursuant to Section D (11), to add one full-time benefitted City staff ("Lead Outreach Worker") for the project; and

WHEREAS, Lead Outreach Worker shall be compensated an amount not to exceed Seventy Thousand Dollars (\$70,000) per year, including salary and benefits; and

WHEREAS, City shall compensate Lead Outreach Worker and invoice Muir on a monthly basis for said compensation.

NOW, THEREFORE, in consideration of the foregoing recitals which are incorporated herein by this reference, Muir and City agree as follows:

1. City will provide one full-time benefitted Lead Outreach Worker for the project.
2. City shall compensate Lead Outreach Worker an amount not to exceed Seventy Thousand Dollars (\$70,000) per year, including salary and benefits.
3. City shall invoice Muir on a monthly basis for compensation made to Lead Outreach Worker, and Muir shall pay to City on a monthly basis the amount invoiced.
4. All terms and conditions of the MOU not inconsistent with this First Amendment, shall remain in full force and effect and are incorporated herein by this reference as if set forth in full.
