

1 RESOLUTION NO.

2 A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIVERSIDE,
3 CALIFORNIA, AMENDING RESOLUTION NO. 22451 KNOWN AS THE
4 MASTER PARKING SCHEDULE RESOLUTION TO REMOVE THE
5 EXISTING 2-HOUR PARKING ZONE AND ESTABLISH A 1-HOUR
6 PARKING ZONE ON MAGNOLIA AVENUE.

7 WHEREAS, the Public Works Department received a petition from 79% of the tenants or
8 owners of the existing commercial parcels located on the south side of Magnolia Avenue from
9 Van Buren Boulevard to east of Farnham Place requesting removal of the existing 2-Hour Parking
10 Zone and the establishment of a 1-Hour Parking Zone to better serve the short-term parking needs
11 of the area businesses; and

12 WHEREAS, businesses indicate that the existing 2-Hour Parking Zone does not provide
13 sufficient turn-over of on-street parking limiting access to patrons. Businesses believe that
14 reducing the time frame allowed for on-street parking at the front of their store fronts from two
15 hours to one hour will allow ample time for patronizing the area businesses and will encourage
16 increased consumer visits; and

17 WHEREAS, on December 7, 2016, the Transportation Board approved staff's
18 recommendation to remove the existing 2-Hour Parking Zone and establish the proposed 1-Hour
19 Parking Zone on the designated segments of the south side of Magnolia Avenue.

20 NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Riverside,
21 California, as follows:

22 Section 1: The recitals set forth above are incorporated herein by reference.

23 Section 2: That the Master Parking Schedule is hereby amended by a) removing the
24 existing "2-Hour Parking between the hours of 9:00 a.m. to 6:00 p.m. Monday through Friday,
25 except holidays" Zone on the south side of Magnolia Avenue from Van Buren Boulevard to east
26 of Farnham Place and b) establishing a "1-Hour Parking between the hours of 9:00 a.m. to 6:00
27 p.m. Monday through Friday, except holidays" Zone on the south side of Magnolia Avenue from
28 Van Buren Boulevard to 150 feet east of Farnham Place.

Section 3: That the provisions of this resolution shall be operative only when signs are erected on that portion of the street set forth in Section 2 above, giving notice of the parking limitations or prohibitions herein established.

Section 4: The provisions of this amendment shall be operative as of the date of adoption of this resolution.
