Carolyn Brodeur spoke about why pape victims delay reporting the crime and the problems that can cause with the police and others.

### Commission Meeting Absences

A) December 14 Regular Meeting – Comphissioner Jackson

Chair Adams noted that Commissioner Jackson was absent due to illness. Commissioner Ortiz made a motion to excuse Commissioner Jackson's absence, and this was seconded by Commissioner Evans. 8 excused the absence; Commissioner Jackson abstained.

#### **Approval of Minutes**

A) December 14 Regular Meeting

Chair Adams asked for a motion to approve the December 14<sup>th</sup> minutes. Commissioner Ortiz asked that language be changed to note that when reporting on the Policies, Procedures, and By-Laws Committee's activities, he had said there was no effective meeting on December 1<sup>st</sup>. A motion was made by Commissioner Ortiz to approve the amended minutes and seconded by Commissioner Ybarra. 8 approvals; Commissioner Jackson abstained.

#### RPD Briefing

Preliminary briefing on the officer-involved death of Dominick W. Smith on December 29, 2016.

Carolyn Brodeur spoke about the effect that officer-involved deaths have on the officers involved in those incidents. She said the press should report on this more often.

Captain Larry Gonzalez briefed the Commission on the Smith incident. Commissioner Jackson asked if there was any communication between Mr. Smith and the officers; Capt. Gonzalez said he didn't believe there was. Chair Adams asked why no press release was issued about this incident. Capt. Gonzalez said press releases aren't always done, but that there should have been in this instance because of it being an in-custody death.

Chair Adams also asked Capt. Gonzalez if family contact information could be sent to the Commission in the future so that the family could be told of the Commission's involvement with the case and when the meeting during which RPD's briefing would be held. Capt. Gonzalez said that that could be done.

Bernadette Lenning, Mr. Smith's sister, spoke about her brother. She noted that while he did have addiction problems and suffered from mental illness, there was another side to him and that he was a much-loved son, grandson, brother, and nephew. She also expressed concern that her family was unaware of the Commission's involvement with the case until reading of it in a newspaper article.

Chair Adams noted that rationales would be discussed at the next meeting. Commissioner Jackson asked where the DA letters were. Ms. Sherron noted that they hadn't been included initially, but that the letters had eventually been sent over from Records and that they would be uploaded to the website by the end of the week

Chair Adams said that an analysis regarding OID and complaint investigations could only be done after a reasonable amount of time had passed since their meetings with RPD and the DA.

Chair Adams said a couple 2017 goals she would like to see take place is the Commission discussion of "totality of circumstances" for OID evaluations and work toward helping RPD implement a program to help police and young people understand each other better.

Commissioner Kurkoske suggested a self-assessment report and Commissioner Ortiz suggested a survey for police officers that is similar to the one prepared for the community. Commissioner Jackson said that RPD roll call follow-up presentations could be done and survey forms could be distributed at that time. Chair Adams said it would be good to have surveys from 1% of the population and the RPD.

#### **Staff Report**

Mr. Hauptmann advised that the CPRC office was now on the 2<sup>nd</sup> Floor. He also noted that the Annual Report would be agendized for February.

#### **Annual CPRC Officer Elections – March 2017**
