## RECITALS

WHEREAS, on or about October 9, 2014, City and Consultant entered into a Professional Consultant Services Agreement for Insurance Consulting and Brokerage Services ("Agreement"); and

WHEREAS, the Agreement will expire on June 30, 2017; and

WHEREAS, City is satisfied with the performance of Consultant; and

WHEREAS, City and Consultant desire to extend the term of the Agreement by three years, to June 30, 2020.

NOW, THEREFORE, in consideration of the foregoing recitals which are incorporated herein by this reference, City and Consultant agree as follows:

- 1. The term of the Agreement is hereby extended by three years, or until June 30, 2020;
- 2. The compensation (Exhibit "B" of the Agreement) will be amended to add the following:

"There will be an annual service fee of \$50,000 with a 3% annual CPI increase for each successive year. The fee schedule will be as follows: \$50,000 for Fiscal Year 2017-2018, \$51,500 for Fiscal Year 2018-2019 and \$53,045 for Fiscal Year 2019-2020 with a total contract price of \$154,545."

3. All terms and conditions of the Agreement not inconsistent with this First Amendment, shall remain in full force and effect and are incorporated herein by this reference as if set forth in full.
