# PURCHASE AND SALE AGREEMENT - CITYMARK DEVELOPMENT, LLC. - DISPOSITION OF SUCCESSOR AGENCY-OWNED LAND - 4019 MISSION INN - RESOLUTION

The Oversight Board (1) adopted a resolution authorizing execution of a Purchase and Sale Agreement with Citymark Development, LLC., in the amount of \$315,000, for the disposition of Successor Agency-owned vacant land, of approximately .64 acres, located at 4019 Mission Inn Avenue, bearing Assessor Parcel Number 214-211-007, for the construction of for-sale luxury townhomes in accordance with the Successor Agency's Long Range Property Management Plan; and (2) authorized the Executive Director, or his designee, to take any and all actions including making minor and non-substantive modifications and execute the Purchase and Sale Agreement as outlined in the written staff report; whereupon, the title having been read and further reading waived, Resolution No. 95 of the Oversight Board for City of Riverside as Successor Agency to the Redevelopment Agency of the City of Riverside Approving a Purchase and Sale Agreement with Citymark Development, LLC., for Property Located at 4019 Mission Inn

Avenue, Identified as Assessor's Parcel Number 214-211-007 to Facilitate Construction of for-Sale Luxury Townhomes, was presented and adopted.
