2 A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF
3 RIVERSIDE, CALIFORNIA, FOR DESIGNATION OF
4 OFFICIAL TO EXECUTE CITY-STATE AGREEMENTS FOR
5 FEDERAL-AID PROJECTS

6 WHEREAS, the Congress of the United States has enacted the Intermodal Surface
7 Transportation Efficiency Acts of 1991 and subsequent Transportation Authorization Bills to
8 fund transportation programs to fund programs including, but not limited to, Surface
9 Transportation Program, the Congestion Mitigation and Air Quality Improvement Program, the
10 Transportation Enhancement Program, the Highway Safety Improvement Program, and the
11 Highway Bridge Program ("Federal-aid Funds"); and

12 WHEREAS, the Legislature of the State of California has enacted legislation by which
13 certain Federal-aid Funds may be made available for use on local transportation facilities of
14 public entities qualified to act as recipients of these Federal-aid Funds in accordance with the
15 intent of federal law; and

16 WHEREAS, before Federal-aid Funds will be made available to the City of Riverside
17 ("City"), the City and state are required to enter into a master agreement and subsequent project-
18 specific program supplements to establish terms and conditions applicable to the City when
19 receiving Federal-aid Funds for a designated project and to the subsequent operation and
20 maintenance of that completed facility; and

21 WHEREAS, the City and the State of California, acting by and through its Department of
22 Transportation, wish to enter into Master Agreement Administering Agency-State Agreement for
23 Federal-Aid Funds ("Master Agreement") number 08-5058F15; and

24 WHEREAS, the City wishes to delegate to the City Manager, or his/her designee, the
25 authority to execute Master Agreement number 08-5058F15, program supplemental agreements,
26 fund exchange agreements, fund transfer agreements, and any amendments thereto, made with
27 the California Department of Transportation.

2 that the City Manager, or his/her designee, is the designated official to execute Master
3 Agreement number 08-5058F15, and all subsequent supplements for specific City projects which
4 are to be funded with Federal-aid Funds.
