3. Executive Director's Report

Mr. Webster thanked the Board for welcoming him to his first Board Meeting. He discussed his objectives for the next two months which were Operational Excellence and identifying high impact areas. Mr. Webster requested to meet with each Board member and their staff individually in the next several weeks to help prepare for the strategic planning all day session that has been scheduled for April 10th at SCPPA.

STAFF REPORTS

4. Government Affairs Report

Ms. Taheri reported on the 15-day ARB 2016 Cap and Trade Amendment language, SCPPA's support on continuation of the program and the following recommendations of improvements for allowance allocation; Opposing POU consignment of allowances to auction, factoring in transportation electrification initiatives for utility sector and to strongly oppose proposed "industrial shifts" of allowances. Ms. Taheri discussed the release of the ARB 2030 Scoping Plan and the reviewed the four alternatives that were presented and the 40% below 1990 Emissions levels.

Ms. DeRivi discussed the SB 350 Integrated Resource Plan, the February 23 Agency Workshop which included the CEC/CPUC GHG target setting and the CEC IRP Guidelines for POU's.

Ms. DeRivi reported on Aliso Canyon, SB 380 Implementation, CPUC/DOGGR workshops and the CPUC order to institute investigation on future facility use and Aliso Canyon SB 57 Extension Moratorium which replaced SB 146 for procedural reasons.

Ms. DeRivi briefed the Board on the State Legislative survey received by members and listed the all topics of interest by priority. Cap and Trade coming in as top priority and the allowance allocation issues.

He also reported on the DNV GL Energy Storage Evaluation and updated the Board of SB 350 Energy Efficiency doubling of energy meaning and targets. Mr. Beatty discussed the 2017 RKS Commercial Survey , the offering of a new enterprise subscription price for members with a 30% reduced price from 2016.
