7	Section 1: Section 13.20.010 of the Riverside Municipal Code is amended in its entirety
8	as follows:
9	Section 13.20.010 Mall EstablishedBoundaries
10	A pedestrian mall is established along the following boundaries:
11	Main Street between the southerly line of Sixth Street and the northerly line of Eleventh
12	Street but excluding from the mall the intersections of Main Street with Mission Inn Avenue
13	(formerly known as Seventh Street), Main Street with University Avenue (formerly known as
14	Eight Street), Main Street with Ninth Street, and Main Street with Tenth Street. This area will be
15	commonly known as a part of "Main Street Riverside."
16	<u>Section 2</u> : The City Clerk shall certify to the adoption of this ordinance and cause
17	publication once in a newspaper of general circulation in accordance with Section 414 of the
18	Charter of the City of Riverside. This ordinance shall become effective on the 30 th day after the date of its adoption
