A RESOLUTION OF THE OVERSIGHT BOARD FOR CITY OF RIVERSIDE AS SUCCESSOR AGENCY TO THE REDEVELOPMENT AGENCY OF THE CITY OF RIVERSIDE AUTHORIZING EXECUTION OF A QUITCLAIM DEED TO JONES HOLDINGS IV, LLC DOING BUSINESS AS JONES WHOLESALE LUMBER, FOR THE RELINQUISHMENT OF A UTILITY EASEMENT LOCATED AT 7027 CENTRAL AVENUE BEARING ASSESSOR PARCEL NUMBERS 189-160-015 AND 032.

WHEREAS, on January 10, 2012, the City Council adopted Resolution No. 22322 re-affirming the authorization of the City of Riverside to become Successor Agency to the Redevelopment Agency of the City of Riverside ("Successor Agency") pursuant to ABx1 26; and

WHEREAS, subsequent legislation entitled "Assembly Bill 1484", signed into law on June 27, 2012, makes substantive amendments to ABx1 26 and specifically includes a requirement, set forth at Health & Safety Code section 34179(e), that all actions taken by the oversight board be adopted by resolution; and

WHEREAS, the property owner, Jones Holdings IV, LLC doing business as Jones Wholesale Lumber ("Owner"), of 7027 Central Avenue, identified as Assessor's Parcel Numbers 189-160-015 and 032 ("Property"), has requested the Successor Agency to relinquish a utility easement that was recorded against the Property on September 13, 1977 by the Riverside County Recorder as Document No. 178425 ("Easement"); and

WHEREAS, the Owner acquired the Property in December of 2016 and plans to build an office building with sufficient parking, a wood outdoor storage yard, and a storage tank on the Property; and WHEREAS, Successor Agency staff has confirmed that the Easement and any property rights

associated therewith are no longer necessary or required by the Public Utilities Department of the City of Riverside; and

WHEREAS, the Successor Agency desires to execute a quitclaim Deed in order to relinquish the Easement to Jones; and

NOW, THEREFORE, BE IT RESOLVED by the Oversight Board for the City of Riverside as the Successor Agency to the Redevelopment Agency of the City of Riverside, as follows:

<u>Section 1</u>: Pursuant to Health & Safety Code section 34181 (e), the Oversight Board for the City of Riverside as the Successor Agency to the Redevelopment Agency of the City of Riverside does

1	hereby: approve the execution of a Quitclaim Deed between the Successor Agency and Jones Holding			
2	IV, LLC doing business as Jones Wholesale Lumber; and direct the Successor Agency to transmit this			
3	resolution to the Department of Finance.			
4	Section 2: Authorize the City Manager on behalf of the Successor Agency to execute the			
5	Purchase and Sale Agreement and all related documents to complete the sale.
