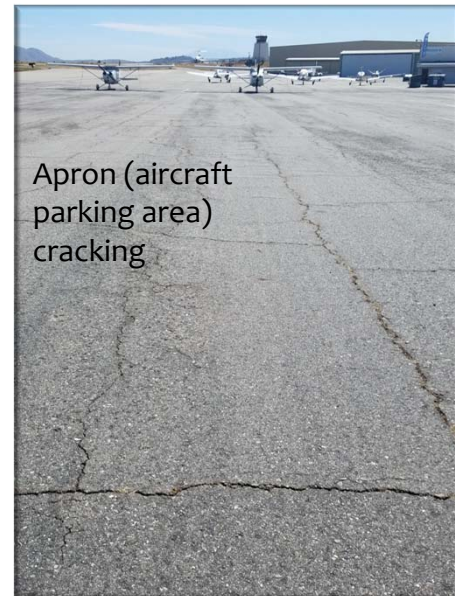
## BACKGROUND

- Acceptance of FAA grant funds for Runway 9/27 and Aircraft Apron
  - Primary runway - 5,401 feet long
  - Estimated project cost: \$971,875
  - April 5, 2016 – City Council authorized acceptance of grant funds for design and engineering services for rehab of the aircraft apron and Runway 9/27
  - June 7, 2016 – City Council approved agreement with Mead & Hunt to complete design and engineering services
  - Winter 2016/17 – Design work completed

## FAA FUNDING PROCESS

- Airport submits 5 year Airport Capital Improvement Plan (ACIP) to the FAA every December
  - Projects submitted may be eligible for federal funding
- City requests Council authority to receive federal and/or state funding
- City retains a consultant according to FAA rules to complete design work for ACIP projects
  - Design for this project is completed
- Construction is bid independently

## RECOMMENDATIONS

- 1 Authorize acceptance of grant funds of \$874,687 from FAA
- 2 Authorize application and acceptance of grant funds of \$43,734.38 from State of California Department of Transportation
- 3 Adopt resolution authorizing application and acceptance of grants from FAA and State of California
- 4 Upon grant awards, appropriate funds to projects accounts as assigned by Finance Department
- 5 In the event State of California funds are not awarded, authorize a supplemental appropriation of \$43,734.38 from the Airport Fund (530)
- 6 Authorize a supplemental appropriation from the Airport Fund (530) in the amount of \$53,453.62 for Airport matching funds
- 7 Authorize City Manager or his designee to execute all grant documents
