A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIVERSIDE, CALIFORNIA, AMENDING RESOLUTION NO. 22451 KNOWN AS THE MASTER PARKING SCHEDULE RESOLUTION TO REVISE THE EXISTING PREFERENTIAL PARKING ZONE ON INDIANA AVENUE.

WHEREAS, the Public Works Department is proposing revision of the existing Preferential Parking Zone ("PPZ") on the north side of Indiana Avenue west of Winstrom Street due to the recent removal of residential structures at the properties located at 7715, 7725 and 7735 Indiana Avenue. <u>Section 1</u>: The recitals set forth above are incorporated herein by reference.

Section 2: That the Master Parking Schedule is hereby amended by revising the boundaries of the existing "No Parking 7:00 a.m. to 10:00 p.m. Daily" Preferential Parking Zone on the north side of Indiana Avenue from "285 feet west of Winstrom Street to 260 feet westerly thereof" to "285 feet west of Winstrom Street to 65 feet westerly thereof."

<u>Section 3</u>: That the provisions of this resolution shall be operative only when signs are erected on that portion of the street set forth in Section 2 above, giving notice of the parking limitations or prohibitions herein established.
