

1 RESOLUTION NO.

2 A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIVERSIDE,
3 CALIFORNIA, AMENDING RESOLUTION NO. 22451 KNOWN AS THE
4 MASTER PARKING SCHEDULE RESOLUTION TO REVISE THE
EXISTING PREFERENTIAL PARKING ZONE ON ELMWOOD DRIVE.

5 WHEREAS, the Public Works Department received a petition from 100% of residents on
6 Elmwood Drive from Elmwood Court to Riverside Avenue requesting revision of the existing 1-
7 Hour Preferential Parking Zone ("PPZ") to change the time limit to a No Parking PPZ and the
8 duration to "6:00 a.m. to 8:30 p.m. Monday through Friday, except holidays" to better suit their
9 current needs; and

10 WHEREAS, the residents indicate that the existing 1-Hour time limit encourages short-
11 term overflow student parking from nearby Riverside City College ("RCC") onto their street and
12 that changing the restriction to a No Parking PPZ would further reduce outside source parking
13 within their neighborhood; and

14 WHEREAS, the residents have further requested that the duration of the PPZ be revised to
15 better align the hours the PPZ is in effect with typical RCC class schedules and exclude Saturdays
16 when overflow student parking is not anticipated; and

17 WHEREAS, the proposed revisions would enhance the effectiveness of the PPZ for
18 residents and help to preserve on-street parking on this segment of Elmwood Drive for residents
19 and their guests; and

20 WHEREAS, on March 1, 2017, the Transportation Board unanimously recommended
21 approval of the proposed revisions to the time limit and duration of the existing PPZ on both sides
22 of Elmwood Drive from Elmwood Court to Riverside Avenue.

23 NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Riverside,
24 California, as follows:

25 Section 1: The recitals set forth above are incorporated herein by reference.

26 Section 2: That the Master Parking Schedule is hereby amended by revising the time limit
27 and duration of the existing Preferential Parking Zone on both sides of Elmwood Drive from
28 Elmwood Court to Riverside Avenue from "1-Hour Parking between the hours of 9:00 a.m. to

1 9:00 p.m. of any day except Sunday and holidays” to “No Parking between the hours of 6:00 a.m.
2 to 8:30 p.m. Monday through Friday, except holidays.”

3 Section 3: That the provisions of this resolution shall be operative only when signs are
4 erected on that portion of the street set forth in Section 2 above, giving notice of the parking
5 limitations or prohibitions herein established.

6 Section 4: The provisions of this amendment shall be operative as of the date of adoption
7 of this resolution.
