14	reflect amendments made to the Riverside Municipal Code.
15	NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Riverside,
16	California, as follows:
17	Section 1: The City Council hereby finds and determines the above recitals are true and
18	correct and incorporates them herein.
19	Section 2: In accordance with the provisions of Section 10.08.040 of the Riverside
20	Municipal Code, and Section 40203.5(a) of the Vehicle Code, Resolution No. 22103, as
21	amended, is hereby amended to revise the Bail Schedule to reflect amendments to the Riverside
22	Municipal Code, which is attached hereto as Exhibit "A" and incorporated herein by this
23	reference.
24	Section 3: The Chief Financial Officer is authorized and directed to revise the Master
25	Fees and Charges Schedule - Parking Enforcement, to reflect and correspond with the
26	amendments, amounts, fees and revisions detailed in Exhibit "A" thereto.
