
APPLICANT: City of Riverside

**Districts** 

PROPOSAL: The Planning Commission recommends to amend the Downtown Specific Plan with regard to permitted and conditionally permitted land uses within the Raincross and Justice Center Districts. Proposed changes to include, but not limited to, Assemblies of People - Entertainment, Assemblies of People - Non-Entertainment, Retail Sales, Brewpubs and Breweries. Other changes not related to permitted and conditionally permitted land uses may be considered that are minor in context, and are necessary for clarification or to remove redundancies. No development or ground disturbance is proposed in conjunction with the proposed Specific Plan Amendment.

**ENVIRONMENTAL DETERMINATION:** The Planning Commission recommends finding that the proposed project is exempt from the California Environmental Quality Act pursuant to Guidelines Section 15061(b)(3), as it can be seen with certainty there is no possibility the proposed amendment will have a significant effect on the environment.
