That certain easement in favor of the City of Riverside Successors in interest to Southern California Edison Company for pole lines, conduits, or underground facilities, and incidental purposes per document recorded August 13, 1973, as Inst. No. 106205 and assigned to the City of Riverside by document recorded May 15, 1989, as Inst. No. 154780, all of Official Records of Riverside County.
