A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIVERSIDE, CALIFORNIA, AMENDING THE DOWNTOWN SPECIFIC 6 (RAINCROSS DISTRICT), AND 7 (JUSTICE CHAPTERS REGARD CENTER DISTRICT) WITH TO PERMITTED CONDITIONALLY **PERMITTED** LAND **USES** WITHIN RAINCROSS AND JUSTICE CENTER DISTRICTS.
