RECITALS

WHEREAS, on October 28, 2013, City and Consultant entered into an Professional Consultant Services Agreement ("Agreement"), for Consultant to provide management services for the Riverside Farmers Market;

WHEREAS, on July 13, 2016, City and Consultant entered into a First Amendment to Professional Consultant Services Agreement ("First Amendment");

WHEREAS, City has been satisfied with Consultant's performance; and

WHEREAS, City and Consultant desire to extend the term of service one additional year and provide additional compensation for the one year period in the amount of Twenty-Six Thousand Dollars (\$26,000).

NOW THEREFORE in consideration of the foregoing recitals, which are incorporated herein by this reference, City and Consultant mutually agree as follows:

- 1. The term of the Agreement is hereby extended by one year, from July 1, 2017 to June June 30, 2018, unless otherwise terminated pursuant to the provisions herein.
- 2. Paragraph 3, Compensation/Payment, of the Agreement is amended by providing that compensation during the extended term of the agreement shall be Twenty-Six Thousand Dollars (\$26,000), made payable in accordance with Exhibit B-1, attached hereto and incorporated herein by this reference.
 - 3. All terms and conditions of the Agreement not inconsistent herewith shall remain in full force and effect and are hereby incorporated by reference into this Second Amendment as though set forth in full herein.

City agrees to pay Market Manager:

Weekly Market Fee:

Market Manager will receive \$26,000 annually upon approval of the contract. The compensation will be paid in fifty-two (52) weekly payments of \$500.00 each.
