

1 RESOLUTION NO.

2 A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIVERSIDE,  
3 CALIFORNIA, ESTABLISHING THE AUTHORIZED AGENTS OF THE  
4 CITY OF RIVERSIDE FOR FILING APPLICATIONS AND REQUESTING  
5 RELEASE OF FUNDS FOR FEDERAL ASSISTANCE FROM FEDERAL  
6 EMERGENCY MANAGEMENT AGENCY, THE CALIFORNIA OFFICE  
7 OF EMERGENCY SERVICES AND/OR STATE FINANCIAL  
8 ASSISTANCE UNDER THE CALIFORNIA DISASTER ASSISTANCE ACT

9 WHEREAS, the City Council of the City of Riverside has the authority to file an application  
10 for federal assistance and request the release of funds from the California Office of Emergency  
11 Services (CalOES) and the Federal Emergency Management Agency (FEMA) and/or state assistance  
12 or disaster relief under the California Disaster Assistance Act; and

13 WHEREAS, CalOES and FEMA require the City to designate authorized agents for the  
14 execution, filing and handling of any such requested assistance; and

15 WHEREAS, the City desires to designate agents to provide for all matters pertaining to such  
16 federal and state disaster assistance the assurances and agreements require; and

17 WHEREAS, the City Council authorizes the Assistant City Manager, the Fire Chief, or the  
18 Emergency Services Administrator to execute and file for and on behalf of the City of Riverside,  
19 applications with CalOES and FEMA for the purpose of obtaining certain federal assistance under  
20 P.L. 93-288 as amended by the Robert T. Stafford Disaster Relief and Emergency Assistance Act of  
21 1988, and/or state financial assistance under the California Disaster Assistance Act.

22 NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Riverside,  
23 California, as follows:

24 Section 1: That the Assistant City Manager, Fire Chief, and/or Emergency Services  
25 Administrator of the City of Riverside are authorized to file any application for the purpose of  
26 obtaining federal assistance under Public Law 93-288 as amended by the Robert T. Stafford Disaster  
27 Relief and Emergency Assistance Act of 1988, and/or state financial assistance under the California  
28 Disaster Assistance Act.

Section 2: The authority granted under this Resolution shall continue in effect for three (3)  
years from the effective date.
