A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIVERSIDE, CALIFORNIA, AMENDING RESOLUTION NO. 21052 TO AMEND PARTS I, II, III AND IV DESCRIBING THE FRINGE BENEFITS AND SALARY PLAN TO REFLECT VARIOUS CHANGES AND UPDATES.

NOW THEREFORE, BE IT RESOLVED by the City Council of the City of Riverside, as follows:

<u>Section 1:</u> The Master Fringe Benefits and Salary Resolution No. 21052, Parts I, II, III and IV are hereby amended as follows:

Section 2: The provisions of this amendment shall be effective upon adoption and operative as set forth in the City Council Memorandum and Attachment "A" as amended and attached hereto.

<u>Section 3:</u> Authorize the City Manager, or his designee, to make minor, non-substantive changes to the Master Fringe Benefits and Salary Plan and any related policies, procedures or documents necessary to implement these provisions.
