ISSUE:

The issue for City Council consideration is the extent of communication and final decision of the Riverside District Attorney as it pertains to the complaint filed by the City Manager against Councilmember Davis.

RECOMMENDATION:

BACKGROUND:

On October 21, 2014, Councilmember Adams announced that the City Council in closed session determined to take no action on the complaint filed by the City Manager against Councilmember Davis and to forward the matter to the District Attorney's Office for independent review and final determination.

In December, 2014, the District Attorney's Office decided to take no action on the referral. A communication was allegedly drafted to Mayor Bailey and Mayor Pro Tempore Adams informing the referring party of that decision. This communication was never finalized and never sent presumably due to the unsuccessful re-election of the District Attorney.

The procedure of notifying the referring party is on an ad hoc basis and in the discretion of the District Attorney.
