Section 1: That the grant award in the amount of Fifty Five Thousand Two Hundred Forty-Seven Dollars (\$55,247.00) from the Department of Alcoholic Beverage Control Grant Assistance to Local Law Enforcement Agencies Project is hereby accepted and the City Manager of the City of Riverside or his designee is hereby authorized and directed to execute the necessary documents in connection therewith, including the grant award contracts or any extensions or amendments thereof.
