- B. On June 22, 2005, due to additional requirements from the State of California, the City and POL entered into a First Amended and Restated Operating Agreement for Access/Homeless Shelter ("Restated Agreement") on the Property.
- C. On October 30, 2015, by a First Amendment to the First Amended and Restated Operating Agreement for Access/Homeless Shelter, the parties extended the term of the Restated Agreement to December 31, 2015, and allowed for the Restated Agreement to be extended again to June 30, 2016.
- D. On January 1, 2016, by a Second Amendment to the First Amended and Restated Operating Agreement for Access/Homeless Shelter, the parties extended the term of the Restated Agreement to June 30, 2016.
- E. On July 27, 2016, by a Third Amendment the First Amended and Restated Operating Agreement for Access/Homeless Shelter, the parties extended the term of the Restated Agreement to June 30, 2017.
- F. The parties now mutually desire to terminate the Restated Agreement and all amendments.

NOW THEREFORE, in consideration of the mutual terms and conditions set forth herein, the parties hereby agree that the First Amended and Restated Operating Agreement for Access/Homeless Shelter and all subsequent amendments thereto, is hereby terminated in its entirety is of no further force and effect.
