

RESOLUTION NO.

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIVERSIDE, CALIFORNIA, RECITING THE FACT OF THE GENERAL MUNICIPAL ELECTION HELD IN SAID CITY ON THE 6TH DAY OF JUNE, 2017, DECLARING THE RESULTS THEREOF AND SETTING FORTH SUCH OTHER MATTERS AS ARE PROVIDED BY LAW.

WHEREAS, a General Municipal Election was held and conducted in the City of Riverside on the 6th day of June, 2017, as required by law for the purpose of electing members of the City Council for Wards 2, 4 and 6; and

WHEREAS, notice of said election was duly and regularly given in the time, form and manner as provided by law; voting precincts were properly established; election officers were appointed and in all respects said election was held and the returns made and declared in the time, form, and manner as required by the provisions of the Charter of the City of Riverside and the Elections Code of the State of California for the holding of elections in the City of Riverside; and

WHEREAS, pursuant to Resolution No. 23136 adopted on the 24th day of January, 2017, the appropriate County official canvassed the returns of said election and has certified the results to this City Council and said results are received, attached, and made a part hereof as Exhibit "A".

NOW THEREFORE, BE IT RESOLVED by the City Council of the City of Riverside, as follows:

<u>Section 1:</u> That there were ten (10) voting precincts in the Second Ward; eleven (11) voting precincts in the Fourth Ward; and (10) voting precincts in the Sixth Ward.

<u>Section 2:</u> That said General Municipal election was held for the purpose of electing three (3) members of the City Council of the City of Riverside from Wards 2, 4, and 6 of the City of Riverside as established by the City Council.

Section 3: That all voter ballots were cast by mail in the City of Riverside; that the whole number of votes cast in the Second Ward in the City of Riverside was 4,341; that the whole number of votes cast in the Fourth Ward in the City of Riverside was 5,673; and that the whole

number of votes cast in the Sixth Ward in the City was 3,909.

<u>Section 4:</u> That the names of the persons voted for at said election and the office which each person was voted for are as follows:

CITY COUNCIL, WARD 2:

That the number of votes given at each precinct and the number of votes given in the City to each of said persons above named for the respective offices for which said persons were candidates are listed on the attached Exhibit "A".

<u>Section 5</u>: That the City Council does declare and determine that Andy Melendrez was elected as a member of the City Council from the Second Ward of said City to serve for the full term of four years.

<u>Section 6:</u> That the City Council does declare and determine that Chuck Conder was elected as a member of the City Council from the Fourth Ward of said City to serve for the full term of four years.

<u>Section 7:</u> That the City Council does declare and determine that Jim Perry was elected as a member of the City Council from the Sixth Ward of said City to serve for the full term of four years.

Section 8: That the City Clerk shall enter on the records of the City Council of said City a statement of the results of the General Municipal election held on June 6, 2017, showing:
