

1 RESOLUTION NO.

2 A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF
3 RIVERSIDE, CALIFORNIA, AMENDING RESOLUTION NO.
4 21052 TO AMEND THE MASTER FRINGE BENEFITS AND
5 SALARY PLAN TO CHANGE THE AUTOMOBILE
6 ALLOWANCE FOR THE CITY CLERK.

7 WHEREAS, on October 4, 2005, Resolution No. 21052 was adopted by the City Council
8 thereby adopting the Master Fringe Benefits and Salary Plan ("FBSP"); and

9 WHEREAS, the FBSP includes the fringe benefits and salary plans for City employees;
10 and

11 WHEREAS, the FBSP has been amended several times to update the benefits and
12 salaries; and

13 WHEREAS, a change in the automobile allowance for the City Clerk has been proposed;
14 and

15 WHEREAS, Table 7 – Automobile Allowance of the FBSP needs to be revised to reflect
16 the proposed change.

17 NOW THEREFORE, BE IT RESOLVED by the City Council of the City of Riverside, as
18 follows:

19 Section 1: Resolution No. 21052 and Table 7 – Automobile Allowance of the Master
20 Fringe Benefits and Salary Plan is hereby amended to reflect the change in the City Clerk's
21 automobile allowance as set forth in Exhibit "A" attached hereto and incorporated herein by
22 reference.

23 Section 2: Authorize the City Manager, or his designee, to make minor, non-
24 substantive changes to the Master Fringe Benefits and Salary Plan and any related policies,
25 procedures or documents necessary to implement these provisions

26 Section 3: The provisions of this resolution shall be operative upon adoption.
