#### APPROVAL OF MINUTES

Motion was made by Member Moran and seconded by Chair Angel approving the December 7, 2016, Transportation Board meeting minutes as presented. Motion carried unanimously with Member Sheth and Member Brown abstaining.

## **DISCUSSION CALENDAR**

#### **ELMWOOD DRIVE – REVISION OF PREFERENTIAL PARKING ZONE**

One resident spoke in support of the request to revise the existing Preferential Parking Zone on Elmwood Drive. Following discussion motion was made by Chair Angel and seconded by Member Moran recommending that the City Council approve revision of the existing PPZ on both sides of Elmwood Drive from Elmwood Court to Riverside Avenue changing the time limit and duration from "1-Hour Parking between the hours of 9:00 a.m. to 9:00 p.m. of any day except Sunday and holidays" to "No Parking between the hours of 6:00 a.m. to 8:30 p.m. Monday through Friday, except holidays." Motion carried unanimously.

#### INDIANA AVENUE - REVISION OF PREFERENTIAL PARKING ZONE

Following discussion motion was made by Member Moran and seconded by Member Armas recommending that the City Council approve revision of the existing "No Parking 7:00 a.m. to 10:00 p.m. Daily" PPZ on the north side of Indiana Avenue west of Winstrom Street changing the zone boundaries from "285 feet west of Winstrom Street to 260 feet westerly thereof" to "285 feet west of Winstrom Street to 65 feet westerly thereof." Motion carried unanimously.

SPEED LIMIT ZONE ESTABLISHMENTS – BARTON STREET AND WELLS AVENUE Following discussion motion was made by Member Sheth and seconded by Member Armas TRANS-1

recommending that the City Council adopt an ordinance to establish a 45 MPH speed limit zone on Barton Street from Van Buren Boulevard to Mariposa Avenue and reduce the existing speed limit on Wells Avenue from Tyler Street to Hole Avenue from 40 MPH to 35 MPH. Motion carried unanimously.

#### **CHAIR AND VICE CHAIR ELECTIONS**

Following a vote by paper ballot, Robert Moran was elected Transportation Board Chair and Jose Armas was elected Transportation Board Vice-Chair.
