

1 RESOLUTION NO.

2 A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF  
3 RIVERSIDE, CALIFORNIA, CREATING A ROSTER OF MUNICIPAL  
4 PARKING FACILITIES & GROUND LEASES FOR PARKING; AND  
5 REPEALING RESOLUTION NOS. 21751 AND 22092.

6 WHEREAS, on September 20, 2010, the City Council adopted Resolution No. 22092  
7 repealing prior resolutions establishing the City's Roster of Municipal Parking Facilities and Ground  
8 Leases for Parking ("Roster"); and

9 WHEREAS, the adoption of Resolution No. 22092 failed to repeal Resolution No. 21751,  
10 which Resolution No. 22092 superseded; and

11 WHEREAS, the City desires to remove lots 10, 16A, 30, 35, 36, 37, 42, 47 and the  
12 Tumbleweed Parking Lot Lease and add lots 44, 50, 51 and Garage 7 to the Roster; and

13 WHEREAS, the City further desires to repeal Resolutions Nos. 21751 and 22092 in their  
14 entirety and adopt this Resolution creating a cleaner and more concise Roster.

15 NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Riverside,  
16 California, as follows:

17 Section 1. The Roster, as set forth in Exhibit "A" attached hereto and incorporated herein  
18 by reference, is hereby adopted as the official list of the City's Municipal Parking Facilities and  
19 Ground Leases for Parking.

20 Section 2: Resolution Nos. 21751 and 22092 are hereby repealed in their entirety.

21 Section 3: The City Council desires to adopt this Resolution which shall make for a  
22 cleaner and more concise document.
