Elevator Replacement Project

- 5. Comprehensive review by HKA Elevator Consulting Inc.
 - A. Replace all mechanical systems
 - B. Replace interior control panels
 - C. Complete mechanical work prior to interior
 - D. Elevator systems beyond useful life
- 6. Frequency of breakdowns is increasing
- 7. Estimated project cost \$1,500,000
