OVERVIEW


- 1. Annual report on the City's General Liability claims activities and costs for Fiscal Year 2016/2017.
- 2. As of June 30, 2017 the City had 240 open claims.
- 3. Total Incurred amount for all open claims is \$8.1 Million
- 4. During FY 2016/17 the City received a total of 697 new claims.

OPEN CLAIMS

- Of the 240 outstanding claims, 155 claims correspond to the Public Works Dept – 15 of which are being handled by the CAO.
- 2. At least 63 of these open claims are related to City trees.
- The Public Works Dept. continues to incur a significant number of liability claims mostly due to the Shamel Ash

CITY ATTORNEY'S OFFICE (CAO) INVOLVEMENT

- 1. CAO has full control of Claims with ongoing litigation.
- 2. Of the 240 currently outstanding claims, 44 claims are being actively administered by the CAO.
- 3. The Total Incurred amount for litigated claims is \$7.1 Million

OUTSIDE LEGAL COUNCIL & LITIGATION COSTS

- 1. The City retains outside legal counsel as applicable and required by the City Attorney's Office.
- 2. Selection of outside legal counsel is conducted by the City Attorney's Office.
- 3. Outside legal fees and costs dating July 1, 2016 through June 30, 2017 were approximately \$1,475,000.


