

1 RESOLUTION NO.

2 A RESOLUTION OF THE CITY COUNCIL OF THE CITY
3 OF RIVERSIDE, CALIFORNIA, AMENDING RESOLUTION
4 NO. 21052 TO AMEND THE MASTER FRINGE BENEFITS
5 AND SALARY PLAN TO EFFECTUATE A SALARY
6 ADJUSTMENT AND TITLE CHANGE OF ECONOMIC
7 DEVELOPMENT/MARKETING MANAGER TO MARKETING
8 OFFICER.

9 WHEREAS, on October 4, 2005, Resolution No. 21052 was adopted by the City Council
10 thereby adopting the Master Fringe Benefits and Salary Plan ("FBSP"); and

11 WHEREAS, the FBSP includes the fringe benefits and salary plans for City employees;
12 and

13 WHEREAS, the FBSP has been amended several times to update the benefits and
14 salaries; and

15 WHEREAS, a title change to the classification of Economic Development/Marketing
16 Manager to Marketing Officer and adjustment to the salary range for the Communications
17 Division in the City Manager's Office has been proposed; and

18 WHEREAS, the Job Code Table of the FBSP needs to be revised to reflect the proposed
19 changes.

20 NOW THEREFORE, BE IT RESOLVED by the City Council of the City of Riverside, as
21 follows:

22 Section 1: Resolution No. 21052, the Job Code Table (Part III) and the Salary
23 Schedule (Part IV) of the Master Fringe Benefits and Salary Plan (Parts III and IV) are hereby
24 amended to reflect a title change to the classification of Economic Development/Marketing
25 Manager to Marketing Officer and adjustment to the salary range for the Communications
26 Division in the City Manager's Office as set forth in Exhibit "A" attached hereto and
27 incorporated herein by reference.

28 Section 2: Authorize the City Manager, or his designee, to make minor, non-
substantive changes to the Master Fringe Benefits and Salary Plan and any related policies,
procedures or documents necessary to implement these provisions

Section 3: The provisions of this resolution shall be operative upon adoption.
