Section 1: Resolution No. 21052, the Job Code Table (Part III) and the Salary Schedule (Part IV) of the Master Fringe Benefits and Salary Plan (Parts III and IV) are hereby amended to reflect a title change to the classification of Economic Development/Marketing Manager to Marketing Officer and adjustment to the salary range for the Communications Division in the City Manager's Office as set forth in Exhibit "A" attached hereto and incorporated herein by reference.

<u>Section 2</u>: Authorize the City Manager, or his designee, to make minor, nonsubstantive changes to the Master Fringe Benefits and Salary Plan and any related policies, procedures or documents necessary to implement these provisions

<u>Section 3:</u> The provisions of this resolution shall be operative upon adoption.
