

1 RESOLUTION NO.

2 A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF
3 RIVERSIDE, CALIFORNIA, AMENDING RESOLUTION NO.
4 21052 TO AMEND THE MASTER FRINGE BENEFITS AND
5 SALARY PLAN TO EFFECTUATE THE CREATION OF A
6 PRINCIPAL PROJECT MANAGER CLASSIFICATION.

7 WHEREAS, on October 4, 2005, Resolution No. 21052 was adopted by the City Council
8 thereby adopting the Master Fringe Benefits and Salary Plan ("FBSP"); and

9 WHEREAS, the FBSP includes the fringe benefits and salary plans for City employees;
10 and

11 WHEREAS, the FBSP has been amended several times to update the benefits and
12 salaries; and

13 WHEREAS, the creation of the classification and salary range for a Principal Project
14 Manager has been proposed; and

15 WHEREAS, the Job Code Table of the FBSP needs to be revised to reflect the proposed
16 changes.

17 NOW THEREFORE, BE IT RESOLVED by the City Council of the City of Riverside, as
18 follows:

19 Section 1: Resolution No. 21052 and the Master Fringe Benefits and Salary Plan are
20 hereby amended to reflect the creation of the classification and salary range for Principal Project
21 Manager as set forth in Exhibit "A" attached hereto and incorporated herein by reference.

22 Section 2: Authorize the City Manager, or his designee, to make minor, non-
23 substantive changes to the Master Fringe Benefits and Salary Plan and any related policies,
24 procedures or documents necessary to implement these provisions

25 Section 3: The provisions of this resolution shall be operative upon adoption.
