17	Section 1: Resolution No. 21052 and the Master Fringe Benefits and Salary Plan are
18	hereby amended to reflect the creation of the classification and salary range for Principal Project
19	Manager as set forth in Exhibit "A" attached hereto and incorporated herein by reference.
20	Section 2: Authorize the City Manager, or his designee, to make minor, non-
21	substantive changes to the Master Fringe Benefits and Salary Plan and any related policies,
22	procedures or documents necessary to implement these provisions
23	Section 3: The provisions of this resolution shall be operative upon adoption.
