- The levy of assessments for the Downtown Parking and Business Improvement Area is hereby imposed for calendar year 2018 on each business entity within the Area at the rate of one hundred percent (100%) of the non-discounted business tax charge paid by that entity, as set forth in Riverside Municipal Code 3.46.060, without regard to any incentive or early payment discounts which may be offered at any given time, and which shall provide specific services and benefits directly to each business entity within the Area subject to the assessment at a cost which does not exceed the reasonable cost in providing the services and benefits.
