

1 RESOLUTION NO.

2 A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIVERSIDE,
3 CALIFORNIA, AMENDING RESOLUTION NO. 22451 KNOWN AS THE
4 MASTER PARKING SCHEDULE RESOLUTION TO ESTABLISH A TIMED
NO PARKING ZONE AT ANTIOCH AVENUE.

5 WHEREAS, the Public Works Department is recommending the establishment of a timed
6 No Parking restriction within the end of the cul-de-sac on Antioch Avenue north of Dewey
7 Avenue to facilitate trash truck navigation of the street; and

8 WHEREAS, the current on-street parking within the cul-de-sac impedes trash trucks
9 from efficiently maneuvering the cul-de-sac to turn around at the end of the street to service the
10 remaining residents; and

11 WHEREAS, the Public Works Department is proposing the establishment of a timed No
12 Parking zone to restrict parking within the end of the cul-de-sac during the scheduled trash pick-
13 up day and time frame; and

14 WHEREAS, sufficient on-street parking for residents and their guests will be available
15 outside of the prohibited area during the restricted day and times; and

16 WHEREAS, on September 6, 2017, the Transportation Board approved staff's
17 recommendation to establish a Timed No Parking Zone on the north side of Antioch Avenue from
18 1260 feet northwest of Dewey Avenue through the cul-de-sac for a length of 115 feet.

19 NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Riverside,
20 California, as follows:

21 Section 1: The recitals set forth above are incorporated herein by reference.

22 Section 2: That the Master Parking Schedule is hereby amended by establishing a "No
23 Parking between the hours of 5:30 a.m. to 3:30 p.m. Thursdays" zone on the north side of Antioch
24 Avenue from 1260 feet northwest of Dewey Avenue through the cul-de-sac for a length of 115
25 feet.

26 Section 3: That the provisions of this resolution shall be operative only when signs are
27 erected on that portion of the street set forth in Section 2 above, giving notice of the parking
28 limitations or prohibitions herein established.

Section 4: The provisions of this amendment shall be operative as of the date of adoption of this resolution.
