

ORDINANCE NO.

AN ORDINANCE OF THE CITY OF RIVERSIDE, CALIFORNIA, AMENDING THE ZONING MAP OF THE CITY OF RIVERSIDE PURSUANT TO CHAPTER 19.090 OF THE RIVERSIDE MUNICIPAL CODE BY REZONING LAND FROM ZONE R-1-7000-SP TO ZONE CG-SP.

The City Council of the City of Riverside, California, does ordain as follows:

Section 1: Pursuant to Chapter 19.090 of the Riverside Municipal Code, the Zoning Map of the City of Riverside is amended by removing from the Single Family Residential Zone ("R-1-7000-SP") and placing in Commercial General and Specific Plan (Riverside Auto Center) Overly Zone ("CG-SP") the property described and depicted in Exhibit "A", attached hereto and incorporated herein by reference, subject to all of the conditions, restrictions and covenants imposed under Planning Case Numbers P16-0617, which conditions, restrictions and covenants are incorporated herein by reference.

Section 2: The City Clerk shall certify to the adoption of this ordinance and cause publication once in a newspaper of general circulation in accordance with Section 414 of the Charter of the City of Riverside. This ordinance shall become effective on the 30th day after the date of its adoption.

PARCEL A - APN 230-100-007 - 7735 Indiana Avenue



Lot 33 of Galeta Manor, as shown by map on file in Book 26, Page 29 of Maps, Records of Riverside County California.

Lot 35 of Galeta Manor, as shown by map on file in Book 26, Page 29 of Maps, Records of Riverside County California.

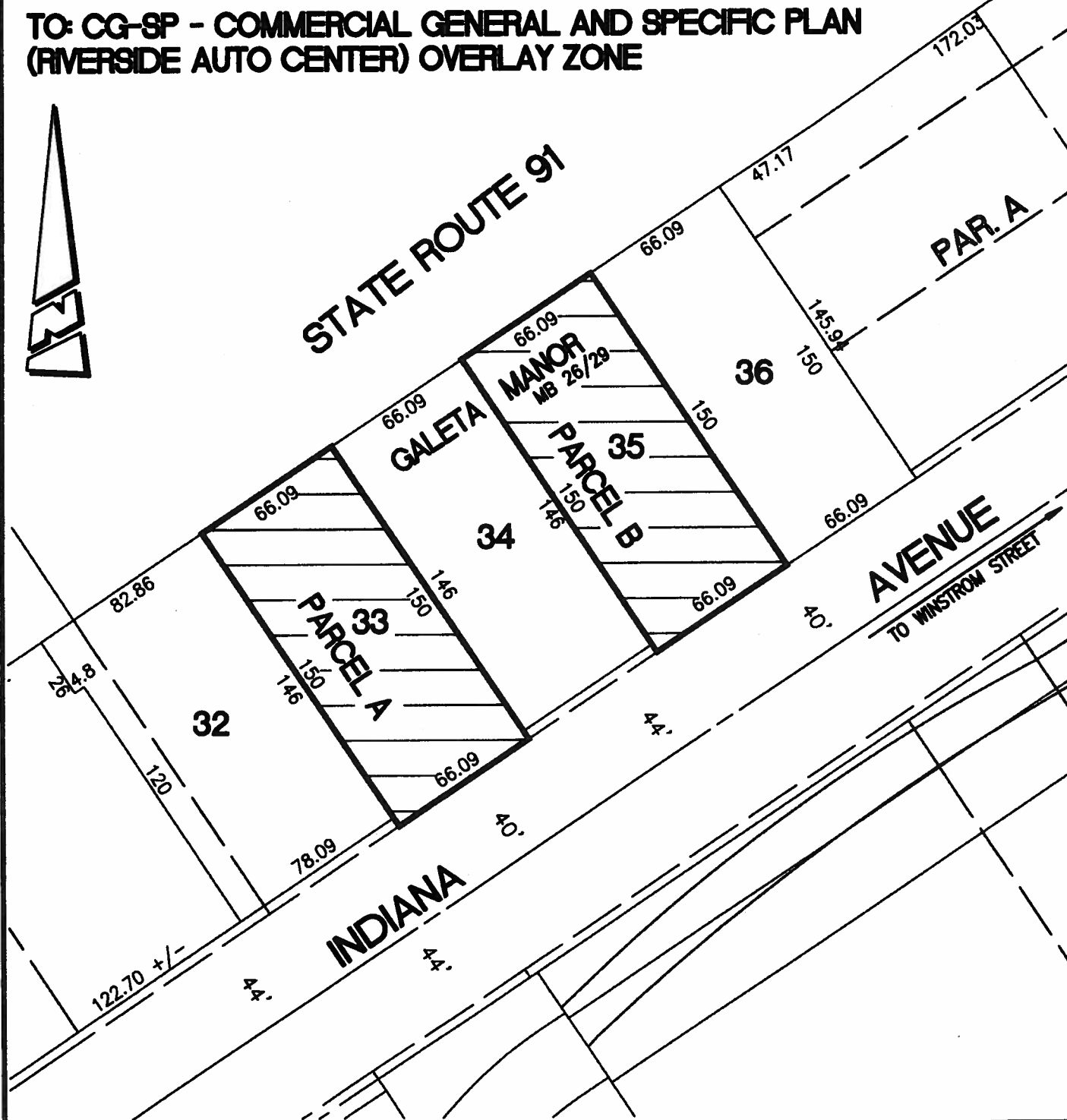
