BACKGROUND:

The Parks, Recreation and Community Services Department (PRCSD) has a Marketing Section under the Recreation Division that actively searches for and accepts donations to help offset expenditures. Donations may be used for specific programming, special events, or contribute to recreation supplies and professional services.

Donations come from a variety of sources, including local businesses, community groups, organizations, and individuals. The PRCSD is appreciative of all donors and expresses its gratitude in a variety of ways, including sending thank you letters, providing donor recognition on brochures, flyers, and advertisements, as well as announcements at programs and events.

DISCUSSION:
