DISCUSSION:

The Mission Square Tesla Charging Station Project was completed on Friday December, 15th, 2017, with final charge testing completed Wednesday, December, 20 2017. With the completion of construction, Tesla has installed 12 supercharging stations at two locations (9th Street and Market Street). This work included the installation of all supporting infrastructure and service connections. At present there are 24 connections available for electric vehicles.

The City of Riverside received positive feedback from Tesla. They said, "I want to say how much of a pleasure it has been to work with you and your team. I was onsite today and continued to be blown away by the level of effort the crews showed for making this project a success. I cannot say how
