III. RECOMMENDATION:

That the Historic Preservation Fund Committee:

1. **APPROVE** the requested one-year time extension for Planning Case P16-0583.

IV. BACKGROUND/HISTORY:

On October 17, 2016, the Historic Preservation Fund Committee unanimously approved the Grant Cycle IV Funding Plan, which included the approval of Planning Case P16-0583, a request by Michele Carry for \$22,807 towards a \$22,807 project reroof and repaint the trim on the house and garage at a single-family residence at 3692 Larchwood Place, a Contributor to the Wood Streets Historic District, Wood Streets Neighborhood Conservation Area, and City Structure of Merit.

Item #9, Project End Date, of the agreement executed by the city states, "The Project shall be completed within one year of the execution of the grant agreement or by June 30, 2018, whichever comes first, or the date any appeals are final. Should any problems arise, a written request for an extension of the project must be submitted to the Historic

Preservation Fund Committee at least 30 days prior to the expiration date." The grant agreement was executed on February 21, 2017.

On December 13, 2017, Staff received a written request from Ms. Carry requesting a time extension to complete the project (Exhibit 1), which is more than 30 days prior to the expiration of the contract. The request expresses that the project completion has been delayed due to the painting contractor being unresponsive, thus requiring Ms. Carry to hire a new contractor.

V. ENVIRONMENTAL ANALYSIS:

It has been determined this project is exempt from the provisions of the California Environmental Quality Act (CEQA) pursuant to Guidelines Section 15331 (Historical Resource Restoration/Rehabilitation).
