A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIVERSIDE, CALIFORNIA, AMENDING RESOLUTION NO. 22451 KNOWN AS THE MASTER PARKING SCHEDULE RESOLUTION TO REVISE THE BOUNDARIES OF THE PREFERENTIAL PARKING ZONE ON LIME STREET.

WHEREAS, the Public Works Department received a request from St. Francis De Sales Catholic Church located at 4268 Lime Street to consider removal of red curb adjacent to their property for the purpose of extending their existing Preferential Permit Parking ("PPZ") on the east side of Lime Street north of Thirteenth Street to provide additional on-street parking within the PPZ and provide additional parking for visitors of the 24-Hour operational adoration chapel after 6:00 p.m. Monday through Friday when the PPZ restriction ends; and

WHEREAS, the church indicates that the need for additional PPZ parking stems from continued overflow parking in the vicinity from area business professionals and more convenient, safe chapel parking which would also be provided is necessitated by an increase in trespassing, vandalism, and homeless activity on the property particularly during evening and night time hours; and

WHEREAS, a review of the existing red curb and travel lane width at this location determined that removal of a 50-foot segment of red curb and extension of the PPZ by the same length was feasible. The proposed revision of the PPZ would help to provide preserved on-street parking at the front of the church during typical business hours and the added benefit of supplying chapel visitors with a few additional on-street parking spaces in close proximity to the chapel entrance after the duration of the PPZ restriction; and

WHEREAS, on December 6, 2017, the Transportation Board unanimously recommended the extension of the existing Preferential Parking Zone boundaries adjacent to St. Francis De Sales Catholic Church located at 4268 Lime Street 50 feet northerly.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Riverside, California, as follows:

<u>Section 1</u>: The recitals set forth above are incorporated herein by reference.

1	Section 2: That the Master Parking Schedule is hereby amended by revising the
2	boundaries of the existing "No Parking between the hours of 9:00 a.m. to 6:00 p.m. except
3	Saturday, Sunday and holidays, with Preferential Parking Permit" zone on the east side of Lime
4	Street from "35 feet north of Thirteenth Street to 58 feet northerly thereof" to "35 feet north of
5	Thirteenth Street to 108 feet northerly thereof" to extend the zone 50' northerly.
6	Section 3: That the provisions of this resolution shall be operative only when signs are
7	erected on that portion of the street set forth in Section 2 above, giving notice of the parking
8	limitations or prohibitions herein established.
9	Section 4: The provisions of this amendment shall be operative as of the date of adoption
10	of this resolution.
