

1 RESOLUTION NO.

2 A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIVERSIDE,
3 CALIFORNIA, AMENDING RESOLUTION NO. 22451 KNOWN AS THE
4 MASTER PARKING SCHEDULE RESOLUTION TO ESTABLISH A
5 PREFERENTIAL PARKING ZONE ON ALTA VISTA DRIVE.

6 WHEREAS, the Public Works Department received a petition showing support from
7 80% of residents on Alta Vista Drive from Brockton Avenue to the westerly terminus requesting
8 establishment of a timed no parking Preferential Parking Zone ("PPZ"). The residents indicate
9 that the regular overflow parking from RCC limits the availability of on-street parking
10 opportunities near their homes and generates additional traffic and noise on their cul-de-sac; and

11 WHEREAS, the establishment of the PPZ would help preserve on-street parking on Alta
12 Vista Drive for residents and their guests during peak school times and aid in reducing
13 unnecessary traffic and noise within the cul-de-sac produced by the student parking; and

14 WHEREAS, on December 6, 2017, the Transportation Board approved staff's
15 recommendation to establish a Preferential Parking Zone on both sides of Alta Vista Drive from
16 Brockton Avenue to the westerly terminus.

17 NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Riverside,
18 California, as follows:

19 Section 1: The recitals set forth above are incorporated herein by reference.

20 Section 2: That the Master Parking Schedule is hereby amended by establishing a "No
21 Parking between the hours of 9:00 a.m. to 4:00 p.m. Monday through Thursday except holidays,
22 with Preferential Permit Parking for residents" zone on both sides of Alta Vista Drive from
23 Brockton Avenue to the westerly terminus.

24 Section 3: That the provisions of this resolution shall be operative only when signs are
25 erected on that portion of the street set forth in Section 2 above, giving notice of the parking
26 limitations or prohibitions herein established.

27 Section 4: The provisions of this amendment shall be operative as of the date of adoption
28 of this resolution.
