6	Clarksdale Drive from Lyon Avenue to the northerly cul-de-sac requesting revision of the existin				
7	1-Hour Preferential Parking Zone ("PPZ") to change the duration to "7:00 a.m. to 8:00 p.m				
8	except Saturday, Sunday, and holidays" to extend the restriction later into the evening; and				
9	WHEREAS, residents indicate that the existing duration of the PPZ no longer meets their				
10	needs, as overflow parking from students attending nearby North-West College has now extended				
11	later into the evenings impacting the availability of on-street parking for residents until 8:00 p.m				
12	weekdays; and				
13	WHEREAS, the proposed revision would enhance the effectiveness of the PPZ for				
14	residents by helping to better preserve on-street parking for residents and their guests during				
15	evening hours; and				
16	WHEREAS, on December 6, 2017, the Transportation Board unanimously recommended				
17	the revision of the duration of the existing Preferential Parking Zone on both sides of Clarksdale				
18	Drive from Lyon Avenue to the northerly cul-de-sac.				
19	NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Riverside				
20	California, as follows:				
21	Section 1: The recitals set forth above are incorporated herein by reference.				
22	Section 2: That the Master Parking Schedule is hereby amended by revising the existing				
23	Preferential Parking Zone on both sides of Clarksdale Drive from Lyon Avenue to the northerly				
24	cul-de-sac to change the duration from "1-Hour Parking between the hours of 7:00 a.m. to 5:00				
25	p.m. except Saturday, Sunday and holidays" to "1-Hour Parking between the hours of 7:00 a.m. to				
26	8:00 p.m. except Saturday, Sunday and holidays."
