6	THE EXECUTION OF ALL REQUIRED DOCUMENTS BY THE CITY MANAGER OR HIS DESIGNEE; AND AMENDING THE DUDGET FOR FISCAL YEAR 2017 2018 ACCORDINGLY
7	BUDGET FOR FISCAL YEAR 2017-2018 ACCORDINGLY.
8	WHEREAS, the U.S. Department of Homeland Security (the "Grantor") has been delegated
9	authority to award federal financial assistance for the Fiscal Year 2017 State Homeland Security
10	Program Grant (SHSP); and
11	WHEREAS, the federal funds have been sub-granted to the California Office of Emergency
12	Services; and
13	WHEREAS, the County of Riverside is the designated Operational Area to which California
14	Office of Emergency Services grant funds are awarded and distributed; and
15	WHEREAS, the City desires to apply for and upon grant award, accept the grant award from
16	the Department of Homeland Security in the amount of \$48,109; and
17	WHEREAS, the City Council desires to amend the annual budget of the City to reflect and
18	incorporate the Grant so awarded to the City, and to increase the annual appropriations and
19	expenditures in the appropriate City program to reflect such award.
20	NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Riverside,
21	California, as follows:
22	Section 1: The City Manager, or his designee, are hereby authorized to submit a grant
23	application for and on behalf of the City of Riverside, through the County of Riverside, and is
24	hereby authorized to execute all actions necessary for the purpose of obtaining federal financial
25	assistance provided by the United States Department of Homeland Security and sub-granted through
26	the State of California, including any extensions and amendments thereof.
27	Section 2: The City Council of the City of Riverside hereby agrees to, and by this Resolution
28	does, accept the Grant funds in the amount of \$48,109 awarded to the City of Riverside.
