SUBJECT: AWARD BID NO. 7500 FOR THE CONSTRUCTION OF STREET WIDENING AT QUIET LANE AND BLEHM STREET TO S&H CIVILWORKS IN THE AMOUNT OF \$53,780

ISSUE:

Award a construction contract for Bid No. 7500 to widen the street pavement section of Quiet Lane and Blehm Street to S&H Civilworks of Colton, California, in the amount of \$53,780.

RECOMMENDATIONS:

That the City Council:

- Award a construction contract for Bid No. 7500 for the Street Widening at Quiet Lane and Blehm Street (Project) to S&H Civilworks of Colton, California, in the amount of \$53,780; and
- 2. Authorize the City Manager, or his designee, to execute the construction contract with S&H Civilworks, including making minor and non-substantive changes.

BACKGROUND:

Quiet Lane is a residential street that connects to Blehm Street at a 90-degree turn west of the La Sierra University. Due to the narrow pavement and steepness of the two streets, sight distance around the turn is limited. Over the years, there have been numerous requests to widen the pavement to improve visibility at Quiet Lane and Blehm Street.

DISCUSSION:

The Street Widening at Quiet Lane and Blehm Street Project will include the following:

- 1. Remove conflicting existing trees, landscaping, irrigation, and retaining wall.
- 2. Minor grading and paving to widen the street pavement section.
- 3. Construct curb and gutter.

4. Install chain link fence.

On January 4, 2018, seven bids were received for the construction of the Project (Attachment 2). The lowest bid came from MGM Construction in the amount of \$48,807.20, but it was deemed unresponsive. The second lowest bid submitted by CT&T Concrete Paving, Inc, in the amount of \$52,449.00 was also deemed unresponsive. The lowest responsive bid was from S&H Civilworks in the amount of \$53,780, which is 7.81% above the Engineer's Estimate.

The Purchasing Manager concurs that the recommended action to award complies with the current Purchasing Resolution.

FISCAL IMPACT:

The estimated total project cost including design, Right-of-Way acquisition, construction, construction engineering, and contingencies is \$93,780. Sufficient funds are available in the project account 9887227-440223 (Blehm & Quiet Knuckle Widening) to provide the funding necessary to award the contract and complete the Project.
