RESOLUTION NO.

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIVERSIDE, CALIFORNIA, FOR PAYING AND REPORTING THE CALPERS RETIREMENT CONTRIBUTIONS FOR TIER 1 EMPLOYEES IN THE RIVERSIDE POLICE OFFICERS' ASSOCIATION UNIT.

WHEREAS, the City Council of the City of Riverside has the authority to implement Government Code Section 20636(c)(4) pursuant to Section 20691; and

WHEREAS, the City Council of the City of Riverside has a written labor agreement which specifically provides for the normal member contributions to be paid for by the employer, and reported as additional compensation; and

WHEREAS, one of the steps in the procedures to implement Section 20691 is the adoption by the City Council of the City of Riverside of a Resolution to commence paying and reporting the value of said Employer Paid Member Contributions (EPMC); pursuant to CCR title 2 section 571(a)(1); and

WHEREAS, the City Council of the City of Riverside has identified the following conditions for the purpose of its election to pay EPMC:

- This benefit shall apply to all Tier 1 employees of the Riverside Police Officers' Association Unit hired between February 17, 2012, and June 12, 2012.
- This benefit shall consist of paying and reporting 1.5% of EPMC to offset the 1.5% employer contribution the employees will be required to pay, in addition to the 7.5% employee contribution, for a total combined contribution of 9%.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Riverside elects to pay and report the value of Employer Paid Member Contributions as set forth above and this resolution shall become effective on March 9, 2018.
