RESOLUTION NO.

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIVERSIDE, CALIFORNIA, APPROVING THE APPLICATION FOR GRANT FUNDS FOR THE CHEECH MARIN CENTER FOR CHICANO ART, CULTURE AND INDUSTRY.

WHEREAS, the Legislature and Governor of the State of California have approved a grant (“Grant”) for the Cheech Marin Center for Chicano Art, Culture and Industry (“Project”); and

WHEREAS, the City of Riverside will be the grantee (“Grantee”) under the Grant; and

WHEREAS, the California Natural Resources Agency has been delegated the responsibility for the administration of the Grant, setting up the necessary procedures; and

WHEREAS, said procedures established by the California Natural Resources Agency require the Grantee to certify by resolution the approval of application before submission of said application to the state; and

WHEREAS, the procedures also require the Grantee to enter into an agreement with the State of California for the Project Grant.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Riverside as follows:

Section 1. The City Council hereby approves the acceptance of general fund allocation for local assistance for the Project.

Section 2. The City Council certifies that it understands the assurances and certification in the Project Information Form.

Section 3. The City Council certifies that it will have sufficient funds to operate and maintain the Project or will enter into an agreement with another entity to perform said operation and maintenance.

Section 4. The City Council certifies that it has reviewed and understands the General Provisions contained in the Project Agreement shown in the Procedural Guide.
