

# Change in Local Limits to Reduce Total Dissolved Solid Levels from Regulated Industries

#### **BACKGROUND**

- The Regional Water Quality Control Plant (RWQCP) National Pollutant Discharge Elimination System Permit (NPDES Permit) requires the City to implement an Industrial Waste Pretreatment Program.
- 2. RMC Section 14.12.350 Local Limits regulates the discharge of pollutants from industrial users to the wastewater system.
- 3. Local Limits are established for priority pollutants to keep levels below that which could impair RWQCP treatment processes or cause pass-through to the Santa Ana River.

### **BACKGROUND**

- 4. Total Dissolved Solids (TDS) is a pollutant that is regulated by Local Limits TDS is essential salts.
- 5. The RWQCP treatment process is not designed to remove TDS and is considered a pass-through pollutant.
- 6. The current local limit of TDS is 2,500 mg/L and was implemented in 2002.
- 7. To change a limit requires a special project. A TDS Sampling Plan was developed to characterize the loading in the collection system.



# **DISCUSSION - TDS SAMPLE PLAN**

- 1. In total, 69 separate samples from sewer manholes were collected.
- 2. RWQCP Environmental Compliance Staff collected the samples.
- 3. RWQCP Laboratory staff conducted the analysis.
- 4. Utilizing in-house staff saved the City approximately \$75,000.

## **DISCUSSION - TDS DEVELOPMENT REPORT**

- 1. Krieger & Stewart Inc., of Riverside CA, was retained to:
  - a. Prepare the Sampling Plan
  - b. Evaluate the TDS Loading to RWQCP
  - c. Develop a proposed TDS Limit
  - d. Prepare a TDS Development Report
- 2. The Project concluded that the TDS Local Limit should be reduced from 2,500 mg/L to 1,210 mg/L.
- 3. Existing Industrial Users should be capped at their current TDS loading discharge level. The new Local Limit would apply to future business expansion.
- 4. Local Limit will apply to all new businesses and sources who discharge into the collection system.

## **DISCUSSION – BUSINESS OUTREACH**

- 1. A review of all available TDS data from over 700 permitted dischargers, about 2% of industrial business, or sixteen (16), will be impacted by the new TDS local limit.
- 2. Over 700 informational letters were sent to all permitted business.
- 3. Contacted the Riverside Chamber of Commerce to provide information on the change and business outreach conducted.
- 4. Sewer Public Benefit Program (Commercial) The City's Sewer Public Benefit Program was approved in 2010 and is available to assist new and existing businesses. The program offers reimbursements for up to fifty percent of the cost of City approved wastewater treatment equipment that reduces pollutant levels. The reimbursement is capped at \$150,000 per customer.

#### DISCUSSION - COMMUNITY SERVICE DISTRICT'S

- 1. Under our wastewater service agreements, the Rubidoux, Jurupa and Edgemont Community Service Districts are required:
  - a. Adopt and implement the proposed Local Limits within their service area jurisdictions.
  - a. Continue to deliver a quality of wastewater to the Regional Water Quality Control Plant which independently complies with the City NPDES permit.
