A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIVERSIDE, CALIFORNIA, AMENDING RESOLUTION NO. 21052 TO AMEND THE MASTER FRINGE BENEFITS AND SALARY PLAN TO ADJUST THE SALARY RANGES OF THE BUSINESS TAX REPRESENTATIVE I, BUSINESS TAX REPRESENTATIVE II, SENIOR BUSINESS TAX REPRESENTATIVE, BUSINESS TAX INSPECTOR AND RISK MANAGEMENT SPECIALIST CLASSIFICATIONS.

WHEREAS, on October 4, 2005, Resolution No. 21052 was adopted by the City Council thereby adopting the Master Fringe Benefits and Salary Plan ("FBSP"); and

WHEREAS, the FBSP includes the fringe benefits and salary plans for City employees; and

WHEREAS, the FBSP has been amended several times to update the benefits and salaries; and

WHEREAS, the Job Code Table of the FBSP needs to be revised to reflect the salary range adjustments that have been proposed for the existing Business Tax Representative I, Business Tax Representative II, Senior Business Tax Representative, Business Tax Inspector and Risk Management Specialist classifications.

NOW THEREFORE, BE IT RESOLVED by the City Council of the City of Riverside, as follows:

Section 1: Resolution No. 21052 and the Master Fringe Benefits and Salary Plan are hereby amended to adjust the salary ranges for the Business Tax Representative I, Business Tax Representative II, Senior Business Tax Representative, Business Tax Inspector and Risk Management Specialist classifications as set forth in Exhibit "A" attached hereto and incorporated herein by reference.

<u>Section 2</u>: Authorize the City Manager, or his designee, to make minor, nonsubstantive changes to the Master Fringe Benefits and Salary Plan and any related policies, procedures or documents necessary to implement these provisions.

<u>Section 3:</u> The provisions of this resolution shall be operative upon adoption.
