## **ISSUES**

1. Receive an update on the Cheech Marin Center for Chicano Art, Culture and Industry (Cheech Marin Center), to be located at the City of Riverside Main Library Building at 3581 Mission Inn Avenue;
2. Approve project conceptual designs; and
3. Adopt a resolution to authorize City Manager submittal of a State grant for renovation, in part, of the existing Main Library Building to become the Cheech Marin Center.

## ASSEMBLY BILL 2214

1. Introduced by Assemblymembers Freddie Rodriguez and Melissa Melendez
2. Establishes a voluntary certification process for recovery residences

## ASSEMBLY BILL 2214 CONT.

3. Certifying organizations would be required to establish and use procedures to administer the application, certification, renewal and disciplinary processes for recovery residences
  - a. Investigate and enforce violations
  - b. Inspect recovery residences, at least annually
  - c. Conduct periodic reviews of the recovery residences
  - d. Inform local jurisdictions and neighbors of complaint procedures; provide contact information
  - e. Revoke certifications if recovery residences are not operating in compliance with certification requirements
  - f. Notify State Department of Health Care Services (State DHCS)

## ASSEMBLY BILL 2214 CONT

4. Local jurisdictions would be able to petition the State DHCS to investigate recovery residences
5. State and County entities would be required to first refer individuals seeking assistance to certified recovery residences

## ASSEMBLY BILL 3162

1. Introduced by Assemblymember Laura Friedman
2. Establishes new provisions for the licensure and operation of alcoholism or drug abuse recovery or treatment facilities
  - a. Overconcentration
  - b. Intensification/expansion of existing facilities

## ASSEMBLY BILL 3162 CONT

3. Increases the penalties for violations of these regulations
  - a. Not less than \$1,000 or more than \$15,000 per day for each violation (current penalties: \$25-\$50)
  - b. Person/entity found to be in violation would be prohibited from applying for a new license for a two-year period
