RESOLUTION NO.

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIVERSIDE, CALIFORNIA, IN SUPPORT OF THE ASSEMBLY BILL 2214 – RECOVERY RESIDENCES.

WHEREAS, sober living homes have proliferated throughout California and exist in the City of Riverside. Some large homes with many residents have the potential to generate secondary effects burdening public services more than other single-family uses, including smaller sober living homes, with fewer people; and

WHEREAS, there is a potential for an increased number of recovery residence housing in the years ahead; and

WHEREAS, Assembly Bill 2214 during the current (2017-2018) Regular Session of the Legislature establishes a voluntary certification process for recovery residences; and

WHEREAS, the Assembly bill defines a "recovery residence" as a residential property that is operated as a cooperative living arrangement to provide an alcohol and drug free environment for persons recovering from alcoholism or drug abuse, or both, who seek a living environment that supports personal recovery;" and

WHEREAS, the Assembly bill provides that a recovery residence would be authorized to demonstrate its commitment to providing a supportive recovery environment by applying and becoming certified for operation by a national certification organization approved by the State's Department of Health Care Services (DHCS); and

WHEREAS, the Assembly bill requires certified residences to meet specified standards; and WHEREAS, the County Behavioral Health Directors Association (CBHDA) supports this bill and states that there is a need for greater accountability for and oversight of recovery residences that provide a drug and alcohol free environment for individuals recovering from substance use disorders,

WHEREAS, the California Consortium of Addiction Programs and Professionals believes that this bill is necessary in order to allow quality recovery residences to continue their important missions; to allow local governments to identify quality homes by certification status; to register complaints and

in order to ensure that these clients are placed in a positive, healthy, and safe environment; and
